Author Cheri Rae will provide background about the people and events that shaped Pearl Chase, as well as how Pearl was able to craft an independent life where she could follow her heart, her interests, and her strong determination to make Santa Barbara a more beautiful place to live.

About the Speaker: Ardent civic activist and award-winning newspaper columnist Cheri Rae is the author of more than 300 articles and commentaries about Santa Barbara and is the longtime editor of

more than 300 articles and commentaries about Santa Barbara and is the longtime editor of "The Capital," newsletter for the Pearl Chase Society. "Channeling her inner Pearl," Cheri led efforts to preserve the city's Bungalow Haven neighborhood, historic buildings, and trees. Equally outspoken on education issues, Cheri spearheads community-wide literacy awareness initiatives. She's director of the Dyslexia Project, was named a "Local Hero" by the Santa Barbara Independent for her fearless efforts on behalf of students with dyslexia and awarded a Resolution from the California State Assembly for her dyslexia work.

Early in her career, Cheri enjoyed successful stints as a magazine editor, holding key management positions with such popular lifestyle magazines. Later in her career, two words describe the direction of Cheri's writing career: worthy causes. She was instrumental in the preservation of the Mojave National Preserve. Her interest in local environment and architecture led her to pen *Walk Santa Barbara*. and, as a nationally known expert on dyslexia, she wrote *DyslexiaLand*, *A Field Guide for Parents of Children of Dyslexia*. Cheri lives with her family in a 1912 bungalow in Santa Barbara's Bungalow Haven, and is now at work on a memoir, *Bungalow Life*.

President's Message by Ted Tazer-Myers



Hello, dear members and friends! It's hard to believe, but we are almost to the end of the fiscal year. To celebrate the Society's achievements during the past twelve months, our multi-talented Mary Jacob is editing the inaugural Year-in-Review report that will be distributed at our Annual Meeting on June 15th. I won't steal its thunder by listing our accomplishments in this column, but you will be amazed at the

surprising number of valuable initiatives and projects that have been implemented during the past year by our creative, talented, and hardworking volunteers. Many thanks to all the department team leaders and committee chairs who contributed content and to Diane Sylvester for layout and design. It looks fantastic!

With the closing of 2023-24, I am starting to look forward to the new fiscal year. I met with one of our long-term members and recent Santa Barbara Foundation Person of the Year, Peter Schuyler, a few weeks ago for coffee. After Peter enthralled me with the story of his illustrious family history, we started talking about the Society's progress in implementing our current strategic plan. I told him we are right on track and that Karen Ramsdell distributes an updated spreadsheet regarding the progress of each initiative and task to our Operations Leadership Team each month, which has both given us collective feedback and held us accountable. Peter then asked me what I was excited about for the coming year. I said there were two things:

First, I am excited about an education initiative led by Diane Sylvester and Chris Klukkert where we will be delivering family history curriculum to local schools. I believe learning one's genealogy and family history is vitally important for students to fill out their concept of who they are and where they come from. If any of you teachers or former teachers and school administrators and staff would like to support this initiative, please let Diane know.

Second, I told Peter that I am looking forward to working with our membership, library, and outreach teams regarding ways to develop more diversity in our collections and membership. To that end, Peter suggested that I meet with Lauren Trujillo, the young, dynamic executive director of the Santa Barbara Library Foundation. Lauren has become well-known in South County for effectively promoting diversity, equity, and inclusion in local nonprofits. She agreed to meet with Laurie Hannah, Mary Jacob, and me last Friday and she shared some excellent, actionable ideas that we look forward to implementing in 2024-25.

So, thank you to Peter for sharing some of your family history and for suggesting that I meet with Lauren, who was quite impressed by her first tour of the Sahyun Library and is now an enthusiastic supporter of our mission. And thank you to all the wonderful members and volunteers who make the Santa Barbara County Genealogical Society such an outstanding place to work, learn, and have fun! The Development Committee is pleased to report on our progress regarding two fundraising efforts that promote the mission of the Society.

Educational Display Systems

The Society has developed a project for replacing outdated educational technology. We want to replace the projector/screen system that we have been using in the Jackson Family Community Room with a smart television with streaming and external audio connection capabilities in our classroom room as well as one in the John Woodward Reading Room. We also plan to purchase a wireless, portable smart board/interactive display board to make presentations clearer, with interactive capabilities that allow us to write on the board and save these ideas digitally. The all-in-one system includes a digital whiteboard, portable stand, an Al camera, microphone, speakers, and innovative styluses.

The funds will also help us replace the Owl video conferencing system with webcams in both the classroom and conference room. These webcams are equipped with microphones and speakers that can tilt, pan the entire room and zoom in when desired, effectively removing the current obstacles we have to communication with our existing, aged system. In addition, two micro-computers, with wireless keyboards and mouse, will be purchased to enable us to maximize the value of the televisions with computer interface from anywhere in the room, significantly enhancing the viewing experience of both streaming online and as an educational tool.

Finally, wall mounts for the televisions, software, display easels, portable monitors and a mobile hotspot (to accommodate up to 32 devices with a 2000 square foot range for events inside the Sahyun Library and outside on our patio) round out the total package of upgraded educational technology.

The entire project is expected to cost \$14,238. We anticipate receiving \$11,000 in support of this project and need to raise an additional \$3,238 more to reach our goal. Please contact Mary Jacob if you would like to contribute to this worthy cause. (Mary Jacob at maryjacob8@gmail.com)

Memorial Patio & Garden

After receiving a generous donation of \$50,000 from the Woodward Family Foundation, we have exceeded the Phase 1 fundraising goal of \$100,000 by over \$10,000! With initial funding secured, Fred Marsh, project manager, was given the green light to initiate conceptual design, engineering, and survey work. Phase 1 will give us a realistic project cost estimate. Phase 2 will focus on additional fundraising and preliminary and final design and approvals, with Phase 3 encompassing permits and construction.

Many thanks to John Woodward, the Williams Corbett Foundation, Mary Jacob, Lori Call, Karen Ramsdell, Fred Marsh, Holly Snyder, and Rosa Avolio for devoting their precious time, energy, expertise and treasure to help bring these projects to their current state of realization.

Books at the Sahyun Chris Klukkert, Book Chair

Summer is soon upon us, and I know that there are some genealogists already on the road to ancestral origins or places. Hopefully, you all have considered checking our library catalog to see what books we might have to help guide you on your research or family trip. My husband and I were in Merced over Memorial Day weekend and made a trip to the nearby historic gold-mining town of Mariposa. Before we left Santa Barbara, I checked the Sahyun catalog on books for Mariposa to give me an idea of places we might want to visit. Helpful to me were our copies of Mariposa Now and Then and also Mariposa County Courthouse, Shrine to Justice. I learned that that courthouse is the oldest court of law in California (1854) and that it allows visitors to view its quaint upstairs courtroom (I felt like I was on the set of To Kill a Mockingbird while walking around up there with its creaky wooden floors, old style wood jury chairs and box, woodstove, and original pane windows.)



During my last library volunteer shift, a visitor to the library asked what books we have on Nebraska. She was going there in late June for a family reunion. She was tasked with preparing some pedigree sheets on her family and was stuck on a few of the family lines.

She was delighted to find we have quite collection of books on Ne-

braska - including one specifically on one of the counties she was visiting (Family Maps of Thomas County, Nebraska : With Homesteads, Roads, Waterways, Towns, Cemeteries, Railroads, and More.) She mentioned that her ancestors were from Czechoslovakia, and that she wasn't quite sure how to start on her Czech roots, and she asked for any hints I might have. Together we pulled out A Handbook of Czechoslovak Genealogical Research and also The Family Tree Polish, Czech & Slovak Genealogy Guide: How to Trace Your Family Tree in Eastern Europe. She was able to take photos of some of the relevant pages she could start in on and also check the biography in the back for further Czech research resources. The topper for her day was finding our book, Czech Heritage families of Nebraska and Kansas. When I left my volunteer librarian shift, she was still immersed in the Nebraska section of the stacks and had set aside some specific pages from the Czech genealogy research books she was going to scan to take back home.

Hmmn, that reminded me. I am going to my paternal side ancestral home of Cheltenham, Gloucestershire, England for the second time in September. Last visit was a whirlwind tour of the more touristy sites and to locate some of the homes of my grandfather's family. I needed to look for myself and sure enough, I found in our stacks the book Hallowed Ground: Churchyards of Gloucestershire and the Cotswolds and also a great map, Gloucestershire, the Glory of the Cotswolds. I know what I will be digging into when I head in next week. How about you?

What books on your family awaits your search? Come into the Sahyun and see for yourself. We look forward to your library visit and we encourage and welcome suggestions for other genealogy books for our collection.



There is my Benjamin Butler and then there are the other ones. Mine was born about 1819 in New York State and is known to have lived in Michigan, Ontario, Iowa, and Missouri (and possibly a few other locations as well). There are other men of that same name who were of about the same age. I'm always

encountering them when I'm looking through records on my Benjamin.

So I made a list of these other Benjamin Butlers and what I have about them – focusing on those who lived reasonably close to my Benjamin and were of about the same age.

I also made a note that there was a Benjamin Butler born in 1818 in New Hampshire who was eventually a governor of Massachusetts. His name comes up in a variety of newspaper searches due to his mention of his political activities. All of that is done so that when I go back to work on my Benjamin after a break, I do not have to start from scratch.



Mary's Bio



I grew up in northern Indiana, attended Macalester College (Minnesota) and headed east to Syracuse University in New York to complete my master's and Ph.D. in geography. While in graduate school I met and married Thomas Jacob, an Indian citizen, and did my dissertation research in India. Thereafter, I taught geography and served as a dean at Mount Holyoke College (Massachusetts) prior to moving to Santa Barbara in 1996 where I held various administrative positions

at UC Santa Barbara before retiring in 2016.

The seeds for my interest in genealogy were planted by two of America's foremost historical geographers with whom I was privileged to study. I remember vividly their lectures about the 1870 federal census and its utility in tracing family migration, the maps they drew of trails and settlement patterns, and their observations about the cultural imprint of ethnic groups on the American landscape. I always said to myself that when I retired, I would study my family history. Indeed, several months before my retirement, I took Norma Eggli's course through adult education on creating your genealogy toolbox. I followed her advice and joined SBCGS a few months after my husband's death. I am currently working on a book about my maternal ancestors. I have also become the family historian for the maternal side of my husband's family. My next trip to India will include visits to archives and churches in Calcutta to do genealogical research.

When I was a beginner genealogist, I appreciated the help I received from SBCGS members so much that I looked for volunteer opportunities to give back to the society. I began as a volunteer librarian on the third Sunday of the month which I did until COVID shut the library. I am now a substitute librarian. I have indexed various types of records including coroner reports that proved fascinating and helped me sharpen my skills at reading handwriting from the past. I am currently Secretary for the Board and a member of the editorial committee of Ancestors West. Though I have never formally joined the Outreach Committee, I volunteered to research and write for the African American exhibit and continue to help with exhibits. While I may not be "officially" involved in an event or activity, I often just pitch in where and when needed. Through my volunteer activities with SBCGS, I have truly enjoyed making friends with people who share similar interests.

NEW MEMBER BENEFITS!

You asked and we listened! In our member-wide survey from last year, many people asked if we could continue the remote access we had to Ancestry.com and GenealogyBank during the pandemic when the library was shut down. Unfortunately, Ancestry. com no longer provides remote access and GenealogyBank has changed its product line for libraries.

However, we are pleased to offer our members remote access to two other services, which we hope will enhance your genealogical research. *Starting July 1, members will have access to MyHeritage and NewspaperArchive, two services that will complement our other suite of subscription databases and provide users with complete access from home.* You will be able to log into these databases from behind our member wall, so you will need to be a member to use them.


NewspaperArchive will complement Newspapers.com, a service the library already subscribes to. It concentrates on many small town newspapers from around the country with strength in the midwest. However, one of the key reasons we decided to subscribe to NewspaperArchive is that it provides coverage of the Santa Barbara News Press from 2005-2023, which Newspapers. com doesn't have.

MyHeritage is known for its international coverage and includes billions of documents from more than 48 countries. There are over 1,300 collections just for Europe alone. It is especially strong in Jewish records from Eastern Europe and Israel. Though you will have access to many records available from other databases we subscribe to in the library, you will be able to access them at home!

The Society will trial these remote services for a year and see how often they are used. Based on user feedback and use statistics, we will evaluate at the end of the fiscal year whether we will continue. As always, we welcome your feedback about library services and what you want from your genealogy society. Stay tuned for more information next month.



Many of you know I have been involved with SBCGS for quite some time in several capacities, Board member, Programs/Education, IT Chair and now Webmaster. The time has come for me to retire from management positions but I will continue to host Lunch and Learn and maybe get to do some genealogy research. Mary Jacob, Development Director

Mary currently serves as Secretary of the Society Board. She has been nominated for the board-appointed position of Development Director. Mary joined the Society in 2016 and serves on the Development Team, Governance Committee, and the editorial team of Ancestors West.

Mary worked at UC Santa Barbara where she held a number of positions until she retired, including Assistant Vice Chancellor for Enrollment Services and Acting Vice Chancellor for Student Affairs. Prior to coming to Santa Barbara, she taught geography at Mount Holyoke College in Massachusetts where she also served as Dean of International Affairs. She is currently president of Friends of Navdanya, a non-profit organization that supports the work of Navdanya, a sustainable organic demonstration farm, seed bank

Proposed Amendments to the Society's Restated Bylaws

<u>Recommendation</u>: The Board of Directors recommends that the membership approve the proposed amendments to Articles 1, 3, 4, and 14 of the Society's Restated Bylaws (Bylaws) dated June 17, 2023.

The Society's Bylaws, adopted on June 17, 2023, are being amended to align with the Society's Amended and Restated Articles of Incorporation, approved by the State of California on October 17, 2023.

The Society has navigated Santa Barbara County's reassessment of our property tax status over the past several years. This issue was resolved in October 2023 with the State's approval of the Amended Articles, resulting in a more favorable property tax classification.

When the Society's Bylaws were amended in June 2023, Articles 1, 3, 4, and 14 contained language from the Society's 1986 Articles because the State's approval of the updated Articles was uncertain at the time.

With the State's approval of the Amended and Restated Articles, it is essential to update the Bylaws to reflect the current language, ensuring consistency and alignment between our governing documents and legal standing.

Following are the proposed changes to Articles 1, 3, 4, and 14 (pages 1, 2, and 11) of the 2023 Bylaws.

RESTATED BYLAWS OF

Santa Barbara County Genealogical Society, Incorporated A California Nonprofit Public Benefit Corporation

ARTICLE 1	CORPORATE NAME
	The name of this corporation is SANTA BARBARA COUNTY GENEALOGICAL SOCIETY, INCORPORATED (Society).
	This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for charitable purposes.
	The Society is a non-profit organization incorporated under the Non-Profit Public Ben- efit Corporation Laws of the State of California.
ARTICLE 3	PURPOSES
	The specific purpose of the corporation is to engage in genealogical and family historical research; to maintain and preserve genealogical resources, information, and records; and to distribute studies of relevant information to the general public.
	This Corporation is organized exclusively for providing public education on matters relating to gene- alogical science within the meaning of Section 501(c)3 of the Internal Revenue Code of 1954 or the corresponding provision of any future United States internal revenue law.
Section 4.2	Prohibited Activities
	The property owned by this corporation is irrevocably dedicated to charitable and educational pur- poses meeting the requirements of the Revenue and Taxation Code section 214, and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member thereof, or to the benefit of any private person.
	All corporate property is irrevocably dedicated to the purposes set forth in Article 2 of the Corporation's Articles of Incorporation. No part of the net earnings of this Corporation shall inure to the benefit of any of its directors, trustees, officers, private shareholders, or members, or individuals.
ARTICLE 14	DISSOLUTION
	Upon the liquidation, dissolution or abandonment of this corporation, its assets, remaining after pay- ment or provision of payment of all debts and liabilities of this corporation, shall be distributed to an organization organized and operated exclusively for charitable and educational purposes meeting the requirements of Revenue and Taxation Code section 214 and which has established its tax-exempt status under Internal Revenue Code section 501(c)3).
	On the dissolution of this Corporation, after paying or adequately providing for the debts, obliga- tions, and liabilities of the Corporation, the remaining assets of the corporation shall be distributed to such organization or organizations organized exclusively for providing public education on matters relating to genealogical science which has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code of 1954 and which has established its tax-exempt status under Section 23701(d) of the California Revenue and Taxation Code.
